11	Act) and the San Francisco Charter Sections 4.114 and B3.581 empower the City and County
12	of San Francisco, acting through the San Francisco Port Commission, with the power and
13	duty to use, conduct, operate, maintain, manage, regulate and control the lands within Port
14	Commission jurisdiction; and
15	WHEREAS, Under Government Code Section 53395 et seq. (IFD Law), this Board of
16	Supervisors is authorized to establish an infrastructure financing district and to act as the
17	legislative body for an infrastructure financing district; and,
18	WHEREAS, Pursuant to Section 53395.8 of the IFD Law, a waterfront district may be
19	divided into project areas; and
20	WHEREAS, On March 27, 2012, by Resolution No. 110-12 (Original Resolution of
21	Intention to Establish IFD), this Board of Supervisors declared its intention to establish a
22	waterfront district to be known as "City and County of San Francisco Infrastructure Financing
23	District No. 2 (Port of San Francisco)" (IFD), and designated initial proposed project areas
24	within the IFD; and

1 WHEREAS, On June 12, 2012, by Resolution No. 227-12 (First Amending Resolution), 2 this Board of Supervisors amended the Original Resolution of Intention to propose, among 3 other things, an amended list of project areas, including Project Area G (Pier 70); and WHEREAS, On November 17, 2015, by Resolution 421-15 (Second Amending 4 5 Resolution, and together with the Original Resolution of Intention to Establish IFD and the 6 First Amending Resolution, the "Resolution of Intention to Establish IFD"), this Board of 7 Supervisors amended the Original Resolution of Intention, as amended by the First Amended 8 Resolution, to propose, among other things, a further amended list of project areas, including Project Area G (Pier 70), as a Pier 70 district, and Sub-Project Area G-1 (Pier 70 – Historic 9 10 Core), as a Pier 70 district; and WHEREAS, In the Resolution of Intention to Establish IFD, this Board of Supervisors 11 12 directed the Executive Director of the Port of San Francisco (Executive Director) to prepare an 13 infrastructure financing plan for the IFD (Infrastructure Financing Plan) that would comply with 14 the IFD Law, and reserved the right to establish infrastructure financing plans in the future 15 specific to other project areas and sub-project areas within the IFD; and, WHEREAS, in accordance with the IFD Law, at the direction of this Board of Directors, 16 17 the Executive Director prepared the Infrastructure Financing Plan; and 18 WHEREAS, On February 23, 2016, by Ordinance No. 27-16 (Ordinance Establishing) IFD), this Board of Supervisors, among other things, declared the IFD to be fully formed and 19 20 established with full force and effect of law and adopted the Infrastructure Financing Plan; 21 WHEREAS, This Board of Supervisors wishes to declare its intention to establish three additional sub-project areas within Project Area G (Pier 70) of the IFD designated Sub-Project 22 23 Area G-2 (Pier 70 - 28-Acre Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-Acre Site); now, therefore, be it 24 RESOLVED, By the Board of Supervisors as follows: 25

Authority. This Board of Supervisors proposes to conduct proceedings to
 establish three additional sub-project areas within Project Area G (Pier 70) of the IFD
 pursuant to the IFD Law; and

- 2. Name of Sub-Project Areas. The names of the proposed sub-project areas are: 4 Sub-Project Area G-2 (Pier 70 - 28-Acre Site). Sub-Project Area G-2 (Pier 70 -5 a. 6 28-Acre Site) shall be a Pier 70 district and a sub-project area within Project Area G (Pier 70). 7 b. Sub-Project Area G-3 (Pier 70 - 28-Acre Site). Sub-Project Area G-3 (Pier 70 -8 28-Acre Site) shall be a Pier 70 district and a sub-project area within Project Area G (Pier 70). 9 c. Sub-Project Area G-4 (Pier 70 - 28-Acre Site). Sub-Project Area G-4 (Pier 70 -28-Acre Site) shall be a Pier 70 district and a sub-project area within Project Area G (Pier 70). 10 3. Amended Boundaries Described. The proposed amended boundaries of the 11 12 IFD, which are amended to include (i) Sub-Project Area G-2 (Pier 70 - 28-Acre Site) within 13 Project Area G of the IFD, (ii) Sub-Project Area G-3 (Pier 70 - 28-Acre Site) within Project Area G of the IFD, and (iii) Sub-Project Area G-4 (Pier 70 - 28-Acre Site) within Project Area 14 15 G of the IFD, are as shown on the amended map of the IFD on file with the Clerk of the Board of Supervisors, which boundaries are hereby preliminarily approved and to which map 16 reference is hereby made for further particulars. 17
- Facilities. The type of public facilities proposed to be financed by Sub-Project
 Area G-2 (Pier 70 28-Acre Site), Sub-Project Area G-3 (Pier 70 28-Acre Site) and Sub Project Area G-4 (Pier 70 28-Acre Site) consist of those listed on Exhibit A to the Original
 Resolution of Intention to Establish IFD, and are particularly described in Appendix G-2to the
 Infrastructure Financing Plan described below. Exhibit A to the Original Resolution of Intention
 to Establish IFD, which lists the type of public facilities proposed to be financed by the IFD,
 including, without limitation, Sub-Project Area G-2 (Pier 70 28-Acre Site), Sub-Project Area

G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-Acre Site), is attached
 hereto and incorporated herein.

5. Incremental Property Tax Revenue. This Board of Supervisors hereby declares that, pursuant to the IFD Law, Sub-Project Area G-2 (Pier 70 - 28-Acre Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-Acre Site) will use incremental property tax revenue from the City but none of the other affected taxing entities within Sub-Project Area G-2 (Pier 70 - 28-Acre Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-Acre Site) (in each case except to the extent permitted by Section 53395.8(h) of the IFD Law) to finance the Facilities.

6. Infrastructure Financing Plan. The Executive Director is hereby directed to 10 prepare an infrastructure financing plan for Sub-Project Area G-2 (Pier 70 - 28-Acre Site) Sub-11 12 Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-Acre Site) as 13 an appendix to the Infrastructure Financing Plan, to be designated Appendix G-2 that complies with the requirements of the IFD Law. Appendix G-2__ shall be a Pier 70 enhanced 14 15 financing plan with respect to Sub-Project Area G-2 (Pier 70 - 28-Acre Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-Acre Site). The Executive 16 17 Director shall cause the Infrastructure Financing Plan to be amended to include Appendix G-18 2__, and, to the extent required by the IFD Law, for the Infrastructure Financing Plan as so amended to be sent to the San Francisco Planning Department and to this Board of 19 20 Supervisors.

7. Public Hearing. This Board of Supervisors will conduct a public hearing on the
 proposed establishment of Sub-Project Area G-2 (Pier 70 - 28-Acre Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-Acre Site) within Project
 Area G (Pier 70) of the IFD, in the Board of Supervisors Chambers, 1 Dr. Carlton B. Goodlett

Place, City Hall, San Francisco, California, on a date to be established by the Executive
 Director, in consultation with the Clerk of the Board of Supervisors.

- 3 8. Notice of Public Hearing. The Clerk of the Board of Supervisors is hereby directed to cause notice of the public hearing to be published not less than once a week for 4 5 four successive weeks in a newspaper designated by this Board of Supervisors for the 6 publication of official notices in the City. The notice shall state that Sub-Project Area G-2 (Pier 7 70 - 28-Acre Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 8 (Pier 70 - 28-Acre Site) will be used to finance Facilities, briefly describe the Facilities and the 9 proposed financial arrangements, including the proposed commitment of incremental tax revenue, describe the boundaries of the proposed Sub-Project Area G-2 (Pier 70 - 28-Acre 10 Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-11 12 Acre Site) and state the day, hour and place when and where any persons having any 13 objections to the proposed Appendix G-2 to the Infrastructure Financing Plan, or the regularity 14 of any of the prior proceedings, may appear before this Board of Supervisors and object to the 15 adoption of the proposed Appendix G-2 to the Infrastructure Financing Plan by this Board of Supervisors. 16
- Further Action. The Clerk of the Board of Supervisors and all other officers and
 agents of the City are hereby authorized and directed to take all actions necessary or
 advisable to give effect to the transactions contemplated by this Resolution.
- 10. No Obligation. This Resolution shall in no way obligate the Board of
 Supervisors to establish Sub-Project Area G-2 (Pier 70 28-Acre Site), Sub-Project Area G-3
 (Pier 70 28-Acre Site) or Sub-Project Area G-4 (Pier 70 28-Acre Site) within the IFD. The
 establishment of Sub-Project Area G-2 (Pier 70 28-Acre Site), Sub-Project Area G-3 (Pier 70
 28-Acre Site) and Sub-Project Area G-4 (Pier 70 28-Acre Site) within the IFD, shall be
 subject to the approval of this Board of Supervisors by ordinance following the holding of the

1	public hearing referred to above. The proposal to include property in the boundaries of Sub-
2	Project Area G-2 (Pier 70 - 28-Acre Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and
3	Sub-Project Area G-4 (Pier 70 - 28-Acre Site) within the IFD does not constitute an approval
4	of any specific land uses on such property.
5	11. California Environmental Quality Act. This Board of Supervisors hereby finds
6	that, pursuant to Title 14, California Code of Regulations, Sections 15378 and 15060(c)(2),
7	adoption of this Resolution and the establishment of Sub-Project Area G-2 (Pier 70 - 28-Acre
8	Site), Sub-Project Area G-3 (Pier 70 - 28-Acre Site) and Sub-Project Area G-4 (Pier 70 - 28-
9	Acre Site) within the IFD are not "projects" under the California Environmental Quality Act
10	because they do not result in a physical change in the environment.
