1. CALL TO ORDER

Lifelines Council Co-Chairs Naomi Kelly and Chris Barkley called the meeting to order at 10:00am.

2. INTRODUCTIONS AND AGENDA REVIEW

City Administrator Naomi Kelly gave opening remarks to the Lifelines Council. She then spoke about the upcoming gap analysis and future table top exercises that will help prepare both the public and private utility providers for their post-disaster response. Co-Chair Chris Barkley gave some remarks regarding the Mayor's Challenge of improving service restoration timelines. Council members asked a few questions regarding City emergency planning efforts and overall public sector response times. City Administrator Naomi Kelly reminded the Council that our focus is on recovery and reducing the time the public is without service(s).

3. PG&E and the City and County of San Francisco

Barry Anderson and Ken Wells from PG&E presented on PG&E's San Francisco Infrastructure Improvements. Their presentation covered the recent Larkin Street Sub-Station outage on April 21, 2017. They then focused on PG&E's 20-year/ \$2.8 billion upgrade program that will conclude in 2025. They highlighted several key projects that have been completed and several that are still in the process of being completed. Their presentation then covers five key emergency initiatives: PG&E's in-house earthquake modeling system (DASH), the carver model, base camp and restoration priorities, PG&E's partnership with UC Berkeley's Shake Alert early earthquake warning system, and their collaboration with external partners, including the Lifelines Council.

4. PORT OF SAN FRANCISCO PRESENTATION ON THE GREAT SEA WALL PROJECT

Steven Reel from the Port of San Francisco gave a presentation on the Port's Seawall Resiliency Project. The presentation covered the original development and history of the Great Sea Wall and the construction of the Embarcadero's famous finger piers. The Port has conducted studies looking at the Sea Wall's vulnerabilities to Sea Level Rise and earthquake hazards and these findings were shared with the Council. The presentation then covered the Port's Emergency Response Map, noting locations of staging areas and where specific staff would be located, after a disaster. Mr. Reel spoke on the Port's continued efforts to work with the private and public utility providers to coordinate and understand the assesses that exists under the Embarcadero roadway, which sit atop the Sea Wall. Lastly, Mr. Reel covered the project's financing and a rough timeline of the project's milestones.

5. OPEN DISCUSSION AND ANNOUNCEMENTS

City Administrator Naomi Kelly recognized Mayor Edwin Lee's Chief of Staff, Jason Elliot, to address the Council. Mr. Elliot informed the Council that he and the Mayor are personally interested and excited about the work of the Council. He spoke to the trust and partnerships that are critical to getting service restored to the city as quickly as possible after a disaster and that he, and the Mayor, are there to assist. He asked the Council members to think about how the Mayor's Office can be helpful to them, particularly in the first 72 hours after a disaster. He ended by saying that if the critical work needed is not done by the Council, then it won't be done at all.
