ESER 2010 Public Safety Building Project

- ESER 2010 has sold \$412.3 million to fully fund all Components
- The Public Safety Building was completed under budget as a result of favorable market conditions and additional funding received from the Mission Bay Developer. Total savings \$8.5 million.





ESER 2014 OCME Project

- The Office of the Chief Medical Examiner, a state of the art facility, was completed and opened for business on November 6, 2017.
- Due to numerous issues including unfavorable market conditions, late-to-emerge Architect/Engineer team errors and omissions, additional client-requested changes, the cost at completion is \$1.3 million over budget.

ESER Transfer of Funds between Components

To mitigate the impact of the Office of the Medical Examiner budget change, a transfer between components is proposed as follows:

- ESER 2010: <u>Increase</u> budget for Neighborhood Fire Stations by \$1.3 million and <u>reduce</u> savings from the Public Safety Building by \$1.3 million.
- ☐ ESER 2014: Reduce budget for Neighborhood Fire Stations by \$1.3 million and increase budget for the Office of the Chief Medical Examiner by \$1.3 million.

The net total funding and scope of work for the Neighborhood Fire Stations across the ESER program is unaffected by this transaction.

This transaction does not require Board of Supervisors approval since it is a transfer between components within the same appropriation.
