- 3. SAN FRANCISCO FLEET WEEK EXERCISE (25 minutes)**

Kendall Lee from San Francisco's Department of Emergency Management will present on the outcomes of this year's Fleet Week Exercise, with particular emphasis on learnings related to the transportation of workers back in to the city after a disaster, route clearance, communications, and regional coordination. A 15-minute presentation will be followed by a discussion and Q&A.

4. UPCOMING FULL SCALE REGIONAL EARTHQUAKE EXERCISE (25 minutes)

Kim Bowman from the Department of Emergency Management will share updates on several upcoming initiatives related to preparing the City and region for a large earthquake. First, she will discuss a full-scale regional earthquake exercise that the City is planning to lead over the next several years, beginning with an updated Hazus run to get an up-to-date understanding of the City's risk. Then she will discuss the department's plans for updating several components of the City's Emergency Response Plan, including the Earthquake Annex. A 15-minute presentation will be followed by a discussion where partners can share their feedback and ideas for the full scale exercise.

5. TSUNAMI WARNING ACTIVATION (20 MINUTES)

Mary Ellen Carroll, Director of the Department of Emergency Management, will share learnings and outcomes of the city's response to the Tsunami Warning issued by the U.S. Tsunami Warning Center on December 5, 2025.

Government's duty is to serve the public, reaching its decision in full view of the public. Commissions, boards, councils, and other agencies of the City and County exist to conduct the people's business. This ordinance assures that deliberations are conducted before the people and that City operations are open to the people's review.
